

# Terms & Conditions

## “ALLIANZ15” 15% Discount to our customers Allianz Travel Insurance Promotion

1. These terms and conditions apply to the use of the promotion code "ALLIANZ15" when purchasing the Eligible Travel Policy through [www.allianztravel.co.nz](http://www.allianztravel.co.nz) for the period commencing from 12.00am on 15<sup>th</sup> June 2026 and ending 11.59pm on 4<sup>th</sup> July 2026 (NZST).
2. Capitalised words in these terms and conditions have the meaning given to them in clause 15 of these terms and conditions.
3. By purchasing the Eligible Travel Policy during the Promotion Period and using the Promotion Code to receive the Discount, You agree to be bound by these terms and conditions.
4. These terms and conditions apply in addition to the Policy Wording of the Eligible Travel Policy, as well as any policy terms, conditions, limits, sub-limits, exclusions, and underwriting criteria that apply in respect of the Eligible Travel Policy.
5. In order to receive the Discount of 15% in respect of the Eligible Travel Policy You must:
  - a. purchase the Eligible Travel Policy during the Promotion Period;
  - b. purchase the Eligible Travel Policy through Our Website; and
  - c. enter the Promotion Code in the box labelled 'Promo Code' when inputting Your travel information on Our Website;
6. You can use the Promotion Code for each Eligible Travel Policy You purchase during the Promotion Period, but may only use it once for each Eligible Travel Policy You purchase.
7. The Discount applied under this promotion cannot be exchanged for cash or any other benefit. This promotion cannot be used in conjunction with any other current offers or discounts provided by Us.
8. The Discount will not be applied unless You enter the Promotion Code prior to completing the purchase of Your Eligible Travel Policy and complete the purchase during the Promotion Period.
9. Other than due to any fault of Our Website, We will not be liable for failure for You to complete the purchase of an Eligible Travel Policy during the Promotion Period, including (without limitation), failure to correctly enter the Promotion Code, Your limited access to internet services, or the failure of any credit card, banking or associated transaction (regardless of the cause of the failure).
10. Employees of AWP Services New Zealand Limited (trading as Allianz Partners) and Mitsui Sumitomo Insurance Company, Limited, as well as the immediate

family members of such employees, are not eligible to participate in this promotion.

11. If You breach these terms and conditions We may require You to pay to Us the value of the Discount You received.
12. We may choose to extend the Promotion Period and will display the new dates and times of the Promotion Period on Our Website and update these terms to reflect the new dates and times of the Promotion Period.
13. We may amend these terms and conditions at any time by publishing the updated terms and conditions on Our Website, provided such amendment is not, in our reasonable opinion, detrimental to You.
14. These terms and conditions are governed by the laws of New Zealand and You submit the exclusive jurisdiction of the courts of New Zealand in respect of any dispute that may arise under them.

#### Definitions

15. In these terms and conditions, unless the context otherwise requires:

"Discount" means a reduction of the price of the Eligible Travel Policy by 15%;

"Eligible Travel Policy" means the Allianz Travel Insurance policy purchased during the Promotion Period;

'Policy Wording' means the policy wording available on Our Website, or otherwise provided to You upon purchasing the Eligible Travel Policy.

"Promotion Code" means the words ALLIANZ15;

16. "Promotion Period" means the period commencing from 12.00am on 15<sup>th</sup> June 2026 and ending 11.59pm on 4<sup>th</sup> July 2026 (NZST);

"Us", "We" and "Our" means Mitsui Sumitomo Insurance Company, Limited acting through AWP Services New Zealand Limited (trading as Allianz Partners);

"Website" means [www.allianztravel.co.nz](http://www.allianztravel.co.nz); and

"You" and "Your" means any person who purchases any Eligible Travel Policy during the Promotion Period.
